# Final Investment Decision Declared

On June 25, 2024, Cedar LNG declared a positive Final Investment Decision (FID) for the world's first Indigenous majority-owned LNG facility. This historic achievement marked the culmination of years of hard work and planning by the Haisla Nation, Pembina Pipeline Corporation, and our industry partners and set the stage for decades of prosperity and environmental leadership.

## **Construction Commences**

Construction commenced shortly after FID in early July 2024, with a focus on the marine terminal area and the pipeline right-of-way, to prepare for a full construction season in 2025. In addition to site clearing work, important environmental management plans have been implemented onsite, including sediment and erosion control measures.



The innovative floating LNG unit is also under development overseas, anticipated for delivery in 2028. # **Proposed Design Refinements**

Cedar LNG is currently pursuing refinements to its approved design based on additional detailed engineering and construction planning. These include an alternate transmission route to avoid impacts on mature trees, the addition of a distribution power line, and an increase in the marine terminal area due to changes in the mooring system.

The proposed refinements are expected to further mitigate environmental effects, while optimizing the project design. The design refinements are subject to the approval of amendments to the project's original Environmental Assessment Certificate and federal Decision Statement.
